

**SUMMARY ANNUAL REPORT FOR
NORTHWESTERN UNIVERSITY EMPLOYEE WELFARE BENEFIT PLAN**

This is a summary of the annual report of the Northwestern University Employee Welfare Benefit Plan (Employer Identification Number 36-2167817, Plan Number 575) for the plan year 01/01/2020 through 12/31/2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Northwestern University has committed itself to pay certain medical expense reimbursement and employee assistance program claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Health Care Service Corporation, Cigna Health and Life Insurance Company, Dearborn Life Insurance Company, Hartford Life and Accident, The Guardian Life Insurance Company of America, Combined Insurance Company of America, Four Ever Life Insurance Company, and Symetra Life Insurance Company to pay certain health, prescription drug, dental, vision, life insurance, accidental death and dismemberment, long-term disability, and business travel accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2020 were \$21,261,491.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$34,324,768 as of the end of plan year, compared to \$22,717,663 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$11,607,105. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$142,250,528 including employer contributions of \$98,606,648, employee contributions of \$43,467,708, and earnings from investments of \$176,172. Plan expenses were \$130,643,423. These expenses included \$6,637,413 in administrative expenses, and \$124,006,010 in benefits paid to participants and beneficiaries and to insurance carriers for the provision of benefits.
